### **INDIA CLIMATE CHANGE & ENVIRONMENTAL DISPUTES DAY**

The global response to climate change is one of the most pressing issues facing society. The Intergovernmental Panel on Climate Change's latest analysis underlines the critical need to stabilise the climate and implement strong and sustained reductions in greenhouse gas emissions to achieve at least net zero emissions by 2050. This rapid and extensive transition requires significant investments, contracts, and regulation, which in turn are generating and will continue to give rise to complex contractual, investment treaty, and other legal disputes.

India is set to be a focal point for climate change and environmental disputes. Such disputes have already arisen in the context of foreign investments, domestic commercial operations, and the environmental impacts of climate change in India. The trend is likely to continue, as India expands its renewable energy capacity, continues its efforts to reduce emissions, develops schemes for emissions trading, emerges as a leader in the issuance of green financial instruments, and attracts investments in new technologies.

In this context, Three Crowns, in collaboration with the Mumbai Centre for International Arbitration, will be hosting the inaugural India Climate Change and Environmental Disputes Day on 10 December 2021. Taking place on Human Rights Day and shortly after the COP 26 UN Climate Change Conference, the event – the first of its kind in India – will examine:

- the types of climate change and environmental disputes arising in India and the fora used to resolve those disputes;
- the international law framework addressing climate change and implications of recent developments in that framework (including COP 26) for countries like India;
- investment treaty arbitrations that have arisen in the context of legislative and regulatory changes by States, as they seek to transition to low carbon, sustainable, and climate resilient economies;
- commercial disputes that may arise in the climate change context, including construction issues, decommissioning of oil and gas assets, emissions trading, and financing disputes;
- implications of recent decisions in common and civil law jurisdictions extending companies' liabilities for ESG failures of foreign subsidiaries and third parties in supply chains; and
- in-house counsel's perspective on the ongoing transition, including impacts on business and operations and approaches to management of risks and disputes.

#### **Gopal Subramanium**

Senior Advocate, Supreme Court of India

Gopal Subramanium is a Senior Advocate at the Supreme Court of India. In 1993, he was designated Senior Advocate suo moto by the Supreme Court, one of the youngest in India's history to receive the designation. Mr. Subramanium served as Solicitor General of India from 2009 to 2011, during which period he was also Chairman of the Bar Council of India. From 2005 to 2009, he served as Additional Solicitor General of India.

Mr. Subramanium is a Foundation Fellow at Somerville College and a Member of the Chancellors Court of Benefactors, the University of Oxford, an Associate Member of 3 Verulam Buildings, London, and a Judge at the Qatar International Court.

In 2009, Mr. Subramanium received the National Law Day Award for Outstanding Jurist from the President of India.



#### Sapan Gupta

General Counsel, ArcelorMittal

Sapan Gupta serves as General Counsel of ArcelorMittal, having previously been General Counsel of ArcelorMittal Nippon Steel (AMNS) and Vice President at ArcelorMittal Group. ArcelorMittal is one of the world's largest steel producers and a global leader in industrials and manufacturing.

Sapan has significant experience in dispute resolution, banking and finance, bankruptcy, fintech, mergers & acquisitions, private equity, capital markets, industrials, manufacturing, and infrastructure. Sapan's prior roles include serving as a Partner and National Practice Head at Shardul Amarchand Mangaldas, Chief Legal Officer at Bajaj Finance, Deputy Head of Legal at Standard Chartered Bank in South Asia, and positions at Sidley Austin, ICICI Bank, HSBC, and Tata Group.
